

Project Highlights

The Philadelphia Property

- 100% owned/controlled – historic high grade gold producer
- 155 drill holes to date
- Only 80 acres of 3300 explored to date. 97 % still to be explored
- 3 kms strike length
- Drilling provides multiple intercepts of high-grade vein
 - 9.04 gpt Au and 34.0 gpt Ag over 20.43 m
 - 5.61 gpt Au and 29.2 gpt Ag over 38.72 m, including: 45.60 gpt Au and 54.9 gpt Ag over 1.19 m
 - 14.5 g/t Au over 1.52 meters within 4.24 g/t over 22.26 m
 - 11.5 gpt Au over 1.59 m and 6.41 gpt gold across 3.69 m
 - 9.20 gpt Au over 4.91 metres
 - 72.5 gpt Au, 16 gpt Ag over 5.16 feet
 - 18.2 gpt Au, 46.6 gpt Ag over 4.86 feet
 - 33.56 gpt Au, 54.7 gpt Ag over 2.35 feet
 - 9.26 gpt Au, 79.8 gpt Ag, 344 gpt Be over 10.76 feet.
 - 23.47 gpt Au, 97.2 gpt Ag over 2.3 feet
 - wide low-grade mineralization in multiple holes
 - 1.34 gpt Au, 5.78 gpt Ag over 377 feet
 - 1.57 gpt Au, 7.64 gpt Ag over 340 feet

- Carlin/stockwork gold system
- Critical mineral antimony greater than 1% in surface sampling
- 100% owned/controlled - 1860 acres
- Past drill results contain 1 to 16 grams gold

Sycamore Canyon Gold-Silver Project

- 31 grams Gold and 553 grams Silver at surface
- 800 Meters long and 110 meters wide to date


